

OVERVIEW

The Redeemer Foundation exists to aid those preparing for full-time or part-time Christian ministry and leadership. Two tracks exist: those preparing to be clergy and those preparing for other ministries supporting the church and communities to expand the Kingdom of God. Refer to the Ministry Areas listed on the Redeemer Website for definitions/examples.

The common element for assistance is that applicant is enrolled in a formal, defined education/training program leading to a degree, certification, or other credential in Christian Ministry.

ASSISTANCE DESCRIPTION

- A limited number of grants are available for financial assistance. Preference is given first to (a) members of or those affiliated with Redeemer Lutheran Church, followed by (b) members of other Lutheran congregations, followed by (c) other Christian congregations.
- The amount of assistance is influenced by the financial need of the student, the number of students submitting applications and the amount of income available from investments for funding.
- Assistance is for tuition and fees, books, supplies and equipment required for classes and, in some cases, partial living expenses during in the course of study.
- Assistance is paid to a student account at the institution and distributed according to the institution's practices. NO ASSISTANCE IS PAID DIRECTLY TO THE STUDENT.
- Assistance will be only awarded for courses related to a student's ministry goal, and not for general classes required for a Associate or undergraduate degree.
- Classes may be in the classroom or on-line.
- Students not completing the course of study or who do not fulfill their Christian ministry obligations will be required to repay the financial assistance according to the terms of **Section H**.

Student Application Process

- 1. Foundation receives a completed application.
- 2. Student meets with the Foundation Board.
- 3. Foundation Board evaluates student application.
- 4. Foundation Board determines assistance distribution among the applicant(s).
- 5. Foundation Board notifies the applicant of the results.

Subsequent years

- 1. A new application is not required unless the student changes the course of study.
- 2. The Board and successful applicants will meet at least once a year, preferably in person, so we the Board can pray with, and encourage the student(s).

Redeemer Foundation Purpose

The intended outcome of this scholarship program is to help increase the number of workers in Christian ministries, both ordained and non-ordained, who will be leaders in fulfilling the Great Commission. Funds released under the program are considered scholarships not requiring repayment <u>except</u> as described under Repayment Conditions, below.

My Statement of Intent

- In consideration of the financial assistance given me by the Redeemer Foundation, I promise to study diligently for the ministry or other Christian leadership positions.
- I intend to enter full-time or part-time Christian ministry, to expand Christ's kingdom, after completing the required course of study.
- I am prepared to serve in Christian ministry, as specified in Assistance Description of my application for at least one (1) full year for each year of financial assistance.
- I understand that Redeemer Foundation board members wish to develop a prayerful, supportive relationship with me. Therefore I will update the Board VP, or other designated member, on my activities and ministry pursuits at the end of each term of study. My updates will include my current phone number and email address.

Repayment Conditions

- Funds received under this financial assistance program of the Redeemer Foundation shall become a non-interest bearing loan, which must be repaid, if I don't complete my studies or serve in Christian ministry.
- In case ill health compels me to leave school, I will notify the Foundation president immediately. In such a case, I will be under no financial obligation to repay any assistance I have received.

Note: The Redeemer Foundation has sole authority to modify terms of repayment of the loans, including forgiving the outstanding balance.
